# Healthy Lifestyles Committee Report 2005 – 2006

The Healthy Lifestyles Project committee created Wiggle, Giggle & Munch (WGM) to fill a gap in programming that existed in the Downtown for 1 to 4 year olds and their parents and to encourage physical activity and healthy eating as a means to address the risks of chronic disease and establish healthy lifestyle habits. The Program was piloted over 8 weeks, April to June, 2004 at two sites and then ran from September 2004 to June 2005 at six different sites, free of charge on a drop-in basis. The evaluation that year indicated participants were happy with the program and staff saw the benefits at a personal level for the participants.

From September 2005 to June 2006 the program was offered twice a week for three sessions at Magnus Eliason Recreation Centre at 430 Langside Street for a total of 28 weeks. This year, Dr. Janice Butcher who conducted the evaluation of the program last year, followed up with participants who attended only once or twice to find out why they were not able to come more often. Only 14 out of 30 families could be reached, which reflects the circumstances of families in the Downtown community. The people reached remembered the program immediately and were generally quite positive about it. Most of them had some conflict that prevented them from coming back.

A major initiative this year for the committee was the creation of a Wiggle, Giggle and Munch Handbook. A final draft is close at hand and a graphic designer has created an inviting and fun "look" for the book.

With this year's experience the committee has concluded that:

- 1. Other organizations within the boundaries of the Communities 4 Families, Downtown Parent Child Coalition (DDPC) should be supported in delivering this program through help from our staff and copies of the Handbook, so that more programs are available for more people.
- 2. It is important to keep a DPCC program available to downtown families and to keep staff experienced in program delivery.
- 3. The program offered needs to maintain the core values parent involvement; education; easy to access (location, financial); substantial period of physical activity and healthy eating.

I would like to thank the other committee members, Judy Barg, Barbara Martin, Laurie Marcella and Sheelagh Smith for sharing the responsibility of this program, which this year included once more hiring program leaders, a writer and graphic designer, choosing a site, developing policy, and hours of discussing and reading handbook rewrites. Their tolerance and humour made the process flow that much more easily and is much appreciated. Our job would have been a lot harder, no impossible, without Ingrid and Genny. More and more of the workload has been transferred to Genny in particular and the committee would like to extend their whole hearted thanks.

# Grants Committee Report 2005 - 2006

#### **Program Description**

The Grant program, now in its third year, was established to distribute grants of various sizes to organizations and groups in the downtown area. Grants under \$1,000.00 can be applied for by groups and organizations (both formal and informal). The application and reporting process are kept as simple as possible to allow groups and organizations with limited report / application writing skills to still qualify. The four pillars of the coalition are used as criteria in determining eligibility. This fiscal year, the coalition has committed \$23,500.00 to the committee.

#### **Program Goals**

The goals of the Grant Program are simple:

- To assist organizations which require funding to carry out activities which support the four pillars
- To provide these grants in a simple application process, with minimal reporting requirements
- To continue the process of advertising the goals and objectives of the Coalition to the community and,
- To continue to develop relationships and partnerships with groups and organizations in the downtown area.

## Literacy Committee Report 2005 - 2006

The Literacy Committee has been fortunate to have been able to put out two calls for Family Literacy project proposals this fiscal year. Some wonderfully innovative projects have been proposed to our committee which have been a pleasure to support. Some of those projects include: an in-home family literacy support program; a summer ESL program for mothers and their children; and a mother tongue literacy program incorporating Bookmates Family Fundamentals as a learning tool.

In the call for proposals, several issues have been highlighted and addressed. One is the need of the refugee community in our community around literacy and family support. We know that it is much better if people are literate in their own language before attempting to become literate in English. We also know that it can be difficult to find funding supports for mother tongue literacy initiatives. Consequently, this is an area of need that we see and in which we have been excited to see initiatives. In order to further support this work the committee will be hosting an ESL Literacy and Parenting Skills (LAPS) training event in the fall.
